Training Day Links Jail Instructors, WTCS and CEA-W

As WTCS ABE-Education Director Peggy Meyers described it, the first Jail Instructor Training Day brought together three legs of a triangle --- jail educators, the Wisconsin Technical College System and CEA-Wisconsin. The Training Day held on Friday, April 25, 2008 at the Pine Ridge Lodge in Wautoma was planned by Peggy and CEA-W Community Corrections Board Member Laurie Jarvis.

The day began with a Meet and Greet. Each of the over 40 participants from about 30 counties introduced themselves and briefly described the programming at their jails.

WTCS President Daniel Clancy expressed his support for the efforts of teachers working in county jails. He emphasized that part of the WTCS mission is to serve overlooked populations, one of which is the incarcerated. He believes that there is natural link between the goals of education and corrections --- that being how education can turn lives around.

In the morning General Session, "Building of Strong Relationships with County Jail Staff", Laurie Jarvis who teaches at the Waushara County Jail teamed with Waushara County Sheriff David Peterson, Jail Administrator George Peterman, and Shift Supervisor Gary Thompson to describe how to build bridges and overcome obstacles that separate the mind-sets of jail teachers and security staff. They gave examples of how at the Waushara County Jail, Laurie took steps to build trust and credibility with the security staff.

In the first afternoon session, Kettle Moraine Correctional Institution Education Director David Picard and Probation and Parole Regional Supervisor Lance Weirsmas played and discussed the DVD New Directions: A Roadmap to Prison Life and Beyond. The film they helped to make details the issues faced by offenders from sentencing, through incarceration, to release. It emphasizes ways that an offender can use programming while incarcerated to turn his life around.

In the final session, Sheboygan County jail instructor Sharon Abel addressed the challenge of “The Constant Flow: Managing the Chaos and Classroom Strategies that Work.” Sharon involved the audience to illustrate techniques for establishing relationships with new students and strategies for making the classroom chaos productive.

Based on the success of this first Jail Instructor Training Day, the Wisconsin Technical College System and CEA-Wisconsin will be considering holding another Training Day next year. All agree, however, we need to come up with a better title for the day.

Jail Literacy Program to Launch in Walworth County

ESL and ABE classes will be taught in the jail

In collaboration with the Walworth County Jail, the Walworth County Literacy Council will introduce a new literacy program at the jail. The jail is located in Elkhorn, and housed 4,180 inmates in 2007. The target start date for the program is the summer of 2008. Two courses will be offered to inmates: 1) Adult Basic Education (ABE) literacy and 2) English as a Second Language (ESL). Initially, class size will be limited to 10 students for both ABE and ESL. The classes will each meet 2 times per week for one hour. The WCLC is currently looking for interested volunteer tutors to teach the classes. The WCLC awaits a grant determination for funding for the project.

The jail literacy project began in the summer of 2007, as the WCLC Board of Directors embarked to research the need and desire for a literacy program within the jail. The first step was to survey each new jail inmate, via a questionnaire. The survey addressed demographics and the need for literacy classes. Board Member John Bigler created the jail survey, and Board Member Terry Schuerman prepared the questionnaire in Spanish. The survey was then distributed by jail staff to each new individual booked in the jail. From June 2007 to December 2007, 567 surveys were completed. The survey results clearly illustrate a need and desire for literacy classes in the Walworth County Jail.

“Beyond their sometimes hardened exterior and beyond the title of their offense, lies an individual who so often wants to change their life but does not know how or where to begin. I have represented individuals charged with everything from the most serious murder to a rather petty theft. My experiences have shown me that there must first be a *desire* to do the hard work to change their lives. Education is the key to change for so many of those incarcerated. Education instills esteem and power—power to leave the criminal ways behind them, to stop making excuses, and to create a brighter tomorrow”, says Brigette Kutschma, former Public Defender in Walworth and Rock counties.

Several national studies have shown that correctional based educational programs have a significant impact on the recidivism rate. For example, a Three State Recidivism Study, published in 2001, focused on 3200 individuals who were released from prison in three states, Maryland, Minnesota and Ohio. The Study evaluated the 3 common areas of recidivism—re-arrest, re-conviction, and re-incarceration—between those who had participated in educational opportunities while incarcerated and those who had not. The Study found that educational participation while incarcerated reduced the likelihood of re-arrest by 13%; reduced the likelihood of re-conviction by 21%; and reduced the likelihood of re-incarceration by 29%. Based on the local need and desire for jail literacy classes, the proven effects of educational jail programming nationwide, and the cooperation of the Walworth County Jail, the WCLC aspires to launch the jail classes this summer. ***If you are interested in this exciting & rewarding tutoring venture, please contact WCLC.***

Nominees cannot be employed by the Department of Corrections, Department of Health and Family Services, or a county jail.



AJA Names Sharon Abel Civilian Employee of the Year

A Wisconsin county jail educator will be honored at the American Jail Association's 27th Annual Training Conference & Jail Expo in Sacramento, California on May 7. Lakeshore Technical College instructor Sharon Abel will be named the recipient of the AJA Civilian Employee of the Year Award for 2008.

Since 1991, Sharon has been responsible for Lakeshore Technical College's Adult Basic & Secondary Education for the Incarcerated Program in Sheboygan County.

According to Corporal Roy Kluss, one of the nominators of Sharon, "When she first started in 1991 our GED/HSED was non-existent. We had a small room with a couple desks, no computer, a few books and no funding to speak of. Since that time she has turned this program into a model for the rest of the state and nation. She is known locally and nationally for the work that she does in and out of our Detention Center. The work Sharon does outside her normal duties including research, grant writing, fund raising, presenting at conferences, coordinating our inmate library and basically anything that's needs to be done shows the dedication she has to her students, LTC, the Sheboygan County Sheriff's Department and our community. Her advocacy for education and life-long learning is contagious and truly makes a difference in the lives of her students and our whole community."

In addition to the AJA award, Sharon was honored as Region III Correctional Education Association Teacher of the Year in 2006.

Commenting on the AJA award, Sharon says, "It is a tremendous honor to have been selected as the American Jail Association's Civilian Employee of the Year 2008. Over the years I have depended on the AJA for learning and networking opportunities. As an instructor and a researcher, I place a high value on the AJA's professional publications especially *American Jails: The Magazine of the American Jail Association*. I am thankful to Cpl. Roy Kluss and Sheriff Michael Helmke for nominating me. Their support along with that of Capt. Karol Salata, Jail Administrator, is very much appreciated. Wanted : Creative Writings and Drawings

Once again, CEA-W invites incarcerated writers and artists to submit their works for the ninth annual edition of the CEA-W Creativity Contest. Each year CEA-W publishes original prose, poetry, and ink drawings from Wisconsin’s jail, prison, and juvenile facility populations. All levels of writers and artists are encouraged to offer submissions. Authors and artists whose works are selected will each receive two free copies of the booklet next January.

Encourage your learners to express themselves in drawings (black ink on 8½ by 11 white paper) and writings up to 1000 words including poems, letters, essays, and short stories. Winners are selected from all levels, so urge beginning writers to give it a try. The deadline for entries is August 1, 2008.

Please ask entrants to read the contest rules and fill out the submission form legibly. Entries can be sent to Libby Kraft at the WRC address on the submission form. Other members of the Creativity Contest Committee are Mary Stierna (WRC), Conrad Reedy (KMCI), Sharon Neemann (WRC), Lisa Packard (RCI), Jane Schirger (RGCI), Mark Terpening (CCI), Jason Brost (SOGS), Linda Lentz (JCBCC), Pandora Lobacz (LHS), Susan Casper (OSCI), Joy Ellen Schuster (Milwaukee County Jail), and Ray Schlesinger (OCI).

The booklets are typeset by inmates at RCI and printed by inmates at CCI. This publication reflects the professional commitment of CEA-W members to promote literacy. Each CEA-W member gets a free copy of the booklet. If you want to join the committee, contact Ray Schlesinger at OCI.

CEA-W – Creativity Contest Rules

1. Entries are limited to writers who are incarcerated in prisons, juvenile facilities, and county jails located in Wisconsin. People in alternative correctional programs such as bracelet monitoring, probation, and parole are not eligible.
2. **All entries must be the original work of the entrant.**
3. Submission emphasis will be placed on those enrolled in educational programs. Special needs students who have received high school diplomas but have skill levels at the basic education level are encouraged to apply.
4. Artwork must be black ink on white paper and allow for at least a one-inch margin around a standard 8.5 x 11” page. Wider and darker lines allow for better reproduction. Photocopies are allowed, but the teacher or representative must see the original work at the time of submission.
5. Writing is judged on voice, organization, and creativity. Any form of writing is acceptable: poems, essays, short stories, letters, etc. Writing can be as short as one paragraph, but should not exceed 1,000 words. Entries must be typed, double-spaced, with a maximum of 2 pages.
6. Only one submission for each category, art and writing, will be accepted from each entrant.
7. The enclosed release form must accompany the entry. The instructor is responsible for explaining that the work will undergo the usual editing process which any publication undergoes. All writing technicalities (punctuation, grammar) will be corrected. Instructors are advised not to correct students’ work. Assistance in writing should include suggestions for expanding ideas, development of themes, and organization. Over-correcting by instructors interferes with the voice of the writer. Entries may be reviewed locally by the Education Director or by DOC Central Office for appropriateness and security consideration as needs and policies dictate.
8. Entries must be signed by the Education Department contact person and received at the address on the release form by August 1, 2008. Winners will receive publications by January 2009. **No submissions will be returned.** Writers whose work is not accepted will not be notified.
9. The writer should include an address where he/she can be contacted in December, 2008. The institutional address can be listed, provided the student agrees to contact the instructor in December about contest results. For jail programs, booklets will be sent to the institutional address in care of the Education Department Contact Person, as listed on the form, for distribution to winners.
10. Writers retain copyright to their work. CEA-W has first publication rights and rights to the collection of work. Winners will receive two (2) copies of the book. No payment for published work will be provided.
11. Students may have their essays published anonymously. The release form, however, must contain the student’s real name and signature. This information will be used by contest coordinator only and kept confidential. Write “anonymous” or use initials (no pseudonyms, please) on the writing submitted, and staple the two together.
12. Illegible submission forms or entries may be disqualified.
